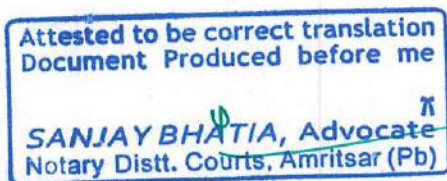

With reference to your application and subsequent correspondence with the school/inspection in this regard, I convey the grant for provisional recognition to the **Sant Giani Kartar Singh Ji Mem. Khalsa Sen. Sec. School, Buraj makhn singh, District Ferozepur** for Class 1st to Class Eighth for a period of ~~Three~~ **Three** Years w.e.f 01-04-2013 to 31-03-2016. The above sanction is subject to fulfillment of following conditions:-

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize affiliate beyond Class VIII.
2. The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 and the Right of Children to Free and Compulsory Education Rules, 2011.
3. The School shall admit in class I, to the extent of 25 % of the strength of that class, children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion.
Provided, that in case of pre primary classes also, this norm shall be followed.
4. For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12 (2) of the Act. To receive such reimbursements school shall provide a separate bank account.
5. The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
6. The School shall not deny admission-
 - a) To any child for lack of age proof.
 - b) If such admission is sought subsequent to the extended period prescribed for admission.
 - c) On the ground of religion, caste or race, place of birth or any of them.
7. The School shall ensure that:
 - a) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
 - b) No child shall be subjected to physical punishment or mental harassment;
 - c) No child is required to pass any board examination till the completion of elementary education;
 - d) Every child completing elementary education shall be awarded a certificate as laid down under Rule 21;
 - e) Inclusion of Students with disabilities/special needs as per provision of the Act;
 - f) The teachers are recruited with minimum qualifications and are provided with minimum salary and allowances as laid under section 23(1) of the Act Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years from the date of commencement of the Act;
 - g) The teacher performs its duties specified under section 24(1) of the Act; and
 - h) The teachers shall not engage himself or herself for private teaching activities.

8. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
9. The School shall enroll students proportionate to the facilities available in the school as prescribed in the section 19 of the Act.
10. The School shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-

7. No remuneration or benefits in money's worth shall be paid or given by the society to any of its members or society expect the actual expenses incurred by the member/ society deputed by the managing body of the society for carrying out duties assigned to them in respect of society.

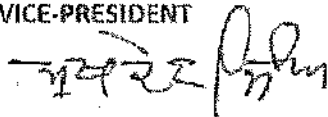
8. No portion of income or the property of the society shall be paid transferred directly or indirectly, to any person or persons save and except for the purposes set out above.

9. The society shall have a body constituted of its members to manage the affairs and this body shall be known as the MANAGING BODY".

10. The minimum member of the society shall be seven and maximum members of the society shall be eleven

11. Every member of the society shall pay a subscription of Rs. 100/- per year as subscription fee.

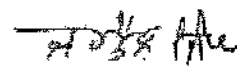

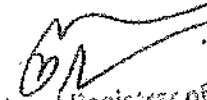

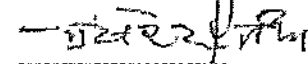

QUALIFICATION AND DISQUALIFICATION OF A MEMBER:

11. The office of the member shall fall vacancy under any of the following circumstances:
 - (a) By death or insolvency.
 - (b) By being adjudged to be of unsound mind by a court of law or a competent Medical Authority.
 - (c) By absence without sufficient cause from three consecutive meetings spreading over a period of one year.
 - (d) By being convicted of an offence involving moral turpitude.
 - (e) By resignation.
 - (f) By non – payment of the subscription for a period of one year and over.
12. The membership vacated under clause 11 shall be filled by nomination by the Chairman / Patron in consultation with the PRESIDENT or Secretary. It shall, however be subject to approval by the managing body by a simple Majority vote in the meeting immediately next following such nomination.
13. The first managing body shall be constituted of the members who are already working on the Managing Body and whose names appear in the memorandum of Association.

• POWERS OF THE MANAGING BODY :

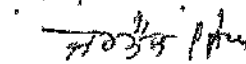

 - (I) To control finance and pass budgets and accounts of the society.
 - (II) To collect funds and use such funds to the best interests of the society.
 - (III) To open account in any bank and to give powers to certain members or authorized person to operate such account (s)
 - (iv) To appoint, promote, demote, suspend, dismiss or remove from service or to grant leave to any of its employees and to regulate service conditions.
 - (v) To control and administer in the best interests of the society and for the benefits of the society all property movable or immovable standing in the name of the society or to be acquired in the name of the society out of the funds of the society, The property, movable, or immovable, so purchased or acquired in the name of any member of the society shall belong to the society.
 - (vi) The managing body any appoint any person as any person as an Auditor of the society to audit its accounts on such terms and conditions as may be decided by the managing Body.
 - (vii) The managing body may do all or any of such acts as may be incidental or conducive to the attainment of the Aims and objects of the society.

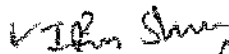

15. The managing body may further frame rules of business or sub – rules for general working of the society.
16. The rules embodied herein shall be regarded as fundamental rules and no changes shall be made in them except by a resolution of the managing body passed by a majority of 2/3rd of members present in meeting and provided further that such resolution forms part of the agenda of the meeting circulated to the members at least a week before the date of meeting.
17. Normally three days notice shall be given for the meeting but an emergent meeting may be called at a shorter notice.

21. **QUORUM:**

Four members present in person shall form the quorum of the meeting.

22. If within fifteen minutes of the time appointed for the meeting, the quorum is not present, the meeting shall stand adjourned. The adjourned meeting shall be held on the same day at the same place in the following week and business shall be transacted even the quorum is not complete as per agenda already circulated. It shall not be necessary to circulate fresh agenda for the adjourned meeting.

23. The meeting of the society shall be held at least four times in a year at a place and time to be notified by the Secretary. The intervening period between the two meetings can be convened, if deemed necessary.

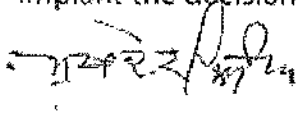
24. The election of the office bearers shall be held after every three years and at least fifteen day notice is required to be given to hold a meeting to elect the office bearers.

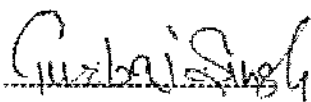
25. Every member shall have a right to move any resolution in the meeting provided. It is in conformity with the aims and objects of the society.

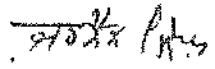
26. On a requisition of five members. The Secretary or the President shall hold, meeting falling which the five members may call and hold a meeting. The Chairman / Patron shall preside over the meeting of the Society / Society .

27. **CHAIRMAN/PATRON:** The Chairman/ Patron shall be a lifelong member of the society but shall be subject to the qualification and disqualification of the members set out in clause 11 above. Baba Harnam Singh Ji Khalsa shall be the Chairman / PATRON of the society hereby constituted and shall hold office for life. He will nominate successor Chairman/ Patron during his lifetime. But in case of his failure to nominate his successor patron/chairman , the patron/chairman shall be elected by the members, either from within the members or from the outside.

28. **PRESIDENT:** The President shall preside over the meetings of the managing body, in his absence of the Chairman / Patron . He shall also responsible to implant the decision taken in the meeting.

33. **SUB COMMITTEE (IES)**

The Governing Body can form Sub-Committee or Committees to run educational, religious , spiritual and social institutions for the purpose to attain the object in general or for a particular project. The President shall be the Chairman (Ex-Officio) of all the Sub-Committees formed as such

34. **GENERAL**

- i) All the provisions under all sections of the Societies Registration Act, XXI of 1860 (Punjab amendment Act,1957) shall apply to this Society.
- ii) 1st April to 31st March shall be the financial year of the Society . All the accounts & other records of the Society / Society shall be maintained as per financial year.
- iii) Once in a year a list of the Governing Body Members including office bearers shall be filed with the Registrar of Societies as required under section 4 of the Act.

iv) The Society may be sued or to be sued in the name of President , Secretary holding office at that time as per provisions laid under section 6 of the Act.

v) Amendments/alterations /extensions or abridgement of purposes, Aims and Objects or change of name may be made as per provision under section 12 and 12-A of the Act.

vi) 2/3rd members of the General Body of the Society / Society can amend the constitution in a special meeting convened for this particular purpose and discussed thoroughly. An agenda may be circulated in advance to every member in this respect.

vii) No member shall have more than one vote in any of the meeting of the Society except that in case of tie ,the Chairman / Patron shall have the privilege of casting vote.

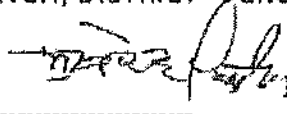
viii) Any person or Society / Institution/Society/community intending to use the property of the Society, shall have to get prior permission of the Chairman/Patron.

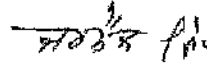
xi) No member is authorized to file any suit against any Office Bearer of the Society / Society without the prior permission of the Governing Body.

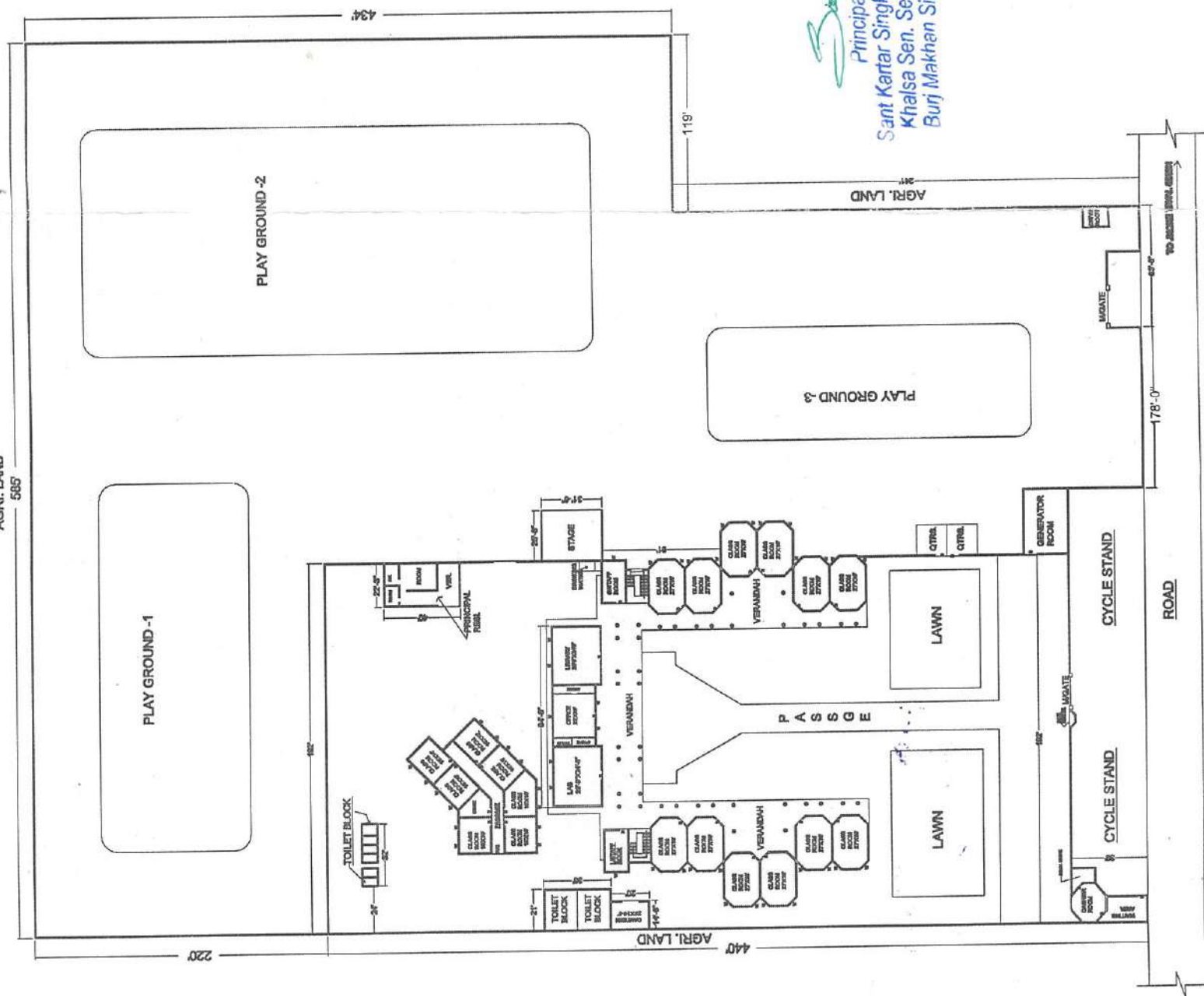
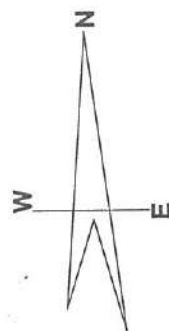

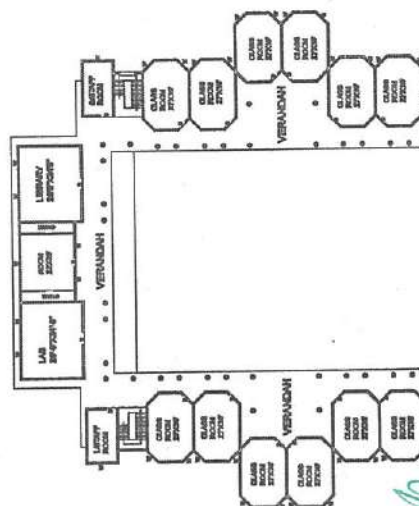
